- 3. The Convener shall check the complaint box daily.
- The Convener along with other members will scrutinize the grievances and will be forward to the respective Sub- Committees/Principal/GB as the case may be for Redressal.
- 5. The Convener shall intimate the follow up action to the complainant.
- 6. The Cell shall take prompt steps for Redressal of grievances relating to irregularity of teachers and employees.
- 7. Anonymous complaints shall also be entertained and enquired.
- 8. The Convener may call emergency sitting of the Cell considering the urgency of redressal of complaints. In such case, the quorum of the Cell will not be essential: otherwise presence of 3 (three) members will forum quorum.
- 6. Dissolution: The Chairman shall have the right to dissolve the Cell if he/she so desires for greater interest of the college.
