Once a selected student accepts the admission offered by the institutions, the institutions will have to click the "Confirm admission" button to complete the admission process in the portal using Institution Login ID on daily basis during admission process latest by 10/05/2025. The institution will be able to confirm admission of only those students who have consistent admission process latest by

The institutions will be able to change the preferred subject(s)/Stream of a student at the time of admission only with due consent from the student and the institution concerned will have to update the same in the portal on the day of admission. 1.	An Applicant has to submit application online through "DARPAN" Portal.	
2,	A student can apply up to maximum of five (5) no. of applications.	
3.	To edit profile of a student, he/she can visit the PROFILE TAB in the student dashboard before preparation of selection list by the institution. The profile of a student can be edited only once.	
4.	The published Selection List and Waiting List for admission into HS first year will be made available in the DARPAN portal for the students. The students will be notified of their selection through SMS.	
5.	After publication of selection list, candidates will be allowed to approve only one institution for admission using their login id in the portal. The candidate must take admission in the institution concerned within the stipulated time period to complete the admission process.	
6.	A student will be able to change their preferred subject(s)/Stream at the time of admission. Students will be able to change their preferred subject(s)/Stream at the time of admission and the institution concerned will have to update the same in the portal on the day	
7.	If a student does not accept the admission offer within stipulated time, the student will be removed from Selection List with information through SMS.
